

Meijer 2016 Wish Snap Share Sweepstakes

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **HOW TO ENTER:** The Meijer 2016 Wish Snap Share Sweepstakes (the “**Sweepstakes**”) begins at 12:01 a.m. EST on November 28, 2016 and ends at 11:59 p.m. EST on December 17, 2016 (the “**Sweepstakes Period**”). Sponsor’s computer is the official time-keeping and counting device for the Sweepstakes. When shopping at Meijer this Holiday season, take a photo (the “**Photo**”) of gifts you are wishing for. If the Photo is a gift for someone other than yourself, tag it with **#gifttogive**. If the Photo is a gift for yourself, tag it with **#gifttokeep**. See excluded items in Paragraph 2 below. Upload and tag the Photo one (1) of four (4) ways as detailed herein:

a) Facebook Entry: Go to www.facebook.com/meijer. Click on the Wish. Snap. Share. tab and follow the directions to complete and submit the entry form.

b) Twitter Entry: Tweet your Photo to @meijer using one of the two hashtags mentioned above.

c) Instagram Entry: Post the Photo and tag @meijerstores with one of the two hashtags mentioned above;

d) SnapChat Entry: Meijer will make available certain geofilters (the “**Filters**”) promoting the Sweepstakes at Meijer stores. To enter, send the Photo using the Filters to meijerstores via Snapchat, adding one of the two hashtags mentioned above.

YOU MUST COMPLY WITH THE TERMS OF USE, COMMUNITY GUIDELINES AND RULES OF FACEBOOK, TWITTER, INSTAGRAM AND SNAPCHAT (COLLECTIVELY, THE “**THIRD PARTY SOCIAL NETWORKS**”). Photo may not be obscene, pornographic, or otherwise inconsistent with the Sponsor's brand or image, and must adhere to the submission requirements herein. Entrants represent and warrant that their photo is the original work of such entrant, has not been copied from others, has not previously won awards, does not violate the rights of any other person or entity, and has not been published previously. Entrants further represent and warrant that publication of the Photo via various media including Web posting will not infringe on the rights of any third party. To submit the Photo, you must have permission from each and every identifiable person or, in the case of minors, the parent or legal guardian of each and every identifiable minor in the photo. Sponsor reserves the right to remove any entry that does not adhere to the requirements of these Official Rules, as determined in Sponsor's sole discretion, and/or disqualify the entrant. All entrants indemnify and hold harmless, Sponsor & Others (as defined in Section 2) from any claims to the contrary.

Submission of an entry grants Sponsor the right to publish, use, adapt, edit and/or modify the photo submission submitted with the entry in any way, in any and all media, without limitation, and without consideration to the entrant.

Entering the Sweepstakes does not make you an automatic winner. **During the Sweepstakes Period, one (1) unique Photo per entry regardless of entry method. Duplicate entries will be disqualified.** Sponsor is not responsible for late, incomplete, invalid, unintelligible, illegible entries, and such entries will be disqualified. Nine (9) entrants will be selected randomly, three (3) each week, during the Sweepstakes Period, and prizes will be awarded in accordance with Sections 3 and 4 below. Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes at any time.

2. **ELIGIBILITY:** You must be a legal resident of the United States living in Illinois, Indiana, Kentucky, Michigan, Ohio or Wisconsin and 18 years of age or older at time of entry. Employees of Meijer Great Lakes Limited Partnership and its parent, subsidiaries, affiliates, representatives or agencies, and their immediate families or persons residing in the same household of such employees (collectively “**Sponsor & Others**”), and other individuals/entities associated with this Sweepstakes, are not eligible to enter or win. This Sweepstakes is void where prohibited or restricted by law and is subject to all applicable federal, state and local laws. Excluded items include: alcohol; tobacco; prescriptions; pharmacy related goods; prepaid phone, gift and entertainment cards; lottery; postage; park and entertainment tickets; prepaid debit cards and reload packs; in store businesses; gas station or c-stop goods; licenses; taxes; previous purchases; SIMPLR protection plans; bottle deposits; curbside purchases; Shipt purchases.

3. **PRIZE, ODDS OF WINNING PRIZE and APPROXIMATE RETAIL VALUE (“ARV”):** The prizes (each, a “**Prize**” collectively, “**Prizes**”) for this Sweepstakes consist of the following: NINE (9) GRAND PRIZES: Meijer will buy the item displayed in your Photo up to a value of \$500 and ship it to you. Total ARV for all Prizes is up to \$4500. Other than shipping of the Prizes (which will be paid for by Sponsor) all other costs associated with the Prizes not specified or mentioned and all applicable federal state and local taxes are the sole responsibility of each winner. Odds of winning depend on the number of eligible entries received from all methods combined. A purchase will not increase your chances of winning. No transfer of Prize, Prize substitution or cash equivalent of Prize is permitted, except at Sponsor’s sole discretion, and then only for a prize of equal or greater value. The Sponsor & Others make no warranty, representation or guarantee, express or implied, in fact or in law, relative to the use of the Prizes including, without limitation, quality, merchantability and fitness for a particular purpose. In the event any component of any Prize is unavailable, Sponsor reserves the right to substitute for a prize of equal or greater value.

4. **DRAWING:** Each week during the Sweepstakes, three (3) random drawings from all eligible entries will be conducted by Meijer to select three (3) potential winners for each Prize. All entries not selected will be automatically included in the remaining drawings. The potential winners will be notified by Meijer on or about the day of the drawing via the Third Party Social Network they entered on, rather than on the Meijer page. The post will include the potential winners Third Party Social Network handle and direct winner to private message Sponsor their contact information. Limit one (1) Prize per person and per household. Each potential winner will be required to sign and return a notarized Affidavit of Eligibility/Compliance (including, without limitation, providing his/her respective Social Security Number for tax purposes) and a Liability/Publicity Release, as allowed by state law, by the return date specified in the prize notification letter. If any required documents are not returned within the required number of days, or if mail is returned to Sponsor, or if the potential winner is ineligible or has otherwise failed to comply with these Official Rules, then the potential winner will be disqualified and Sponsor will have the right to select an alternate winner or deem the Prize un-awarded.

6. **LIMITATIONS OF LIABILITY.** Entrant agrees that Sponsor & Others and the Third Party Social Networks are not responsible or liable for and entrant hereby releases Sponsor & Others and the Third Party Social Networks from any claims arising from: (1) incorrect or inaccurate transcription of entry information or late, lost, stolen, illegible, incomplete, misdirected, or entries received through impermissible or illegitimate channels, all of which will be disqualified; (2) technical failures of any kind, including but not limited to the malfunctioning of any telephone, computer, network, hardware or software; (3) the unavailability or inaccessibility of any service; (4) unauthorized human intervention in any part of the entry process or the Sweepstakes; (5) electronic or human error which may occur in the administration of the Sweepstakes or the processing of entries; or (6) any injury or damage to persons or property, including but not limited to entrant’s computer, which may be caused, directly or indirectly, in whole or in part, from entrant’s participation in the Sweepstakes or from downloading any material from Sponsor’s Website(s), regardless of whether the material was prepared by any Sponsor, or a third party, and regardless of whether the material is connected to a Sponsor’s Website by a hypertext link.

8. **GENERAL CONDITIONS: NO PURCHASE IS NECESSARY TO WIN A PRIZE.** Sweepstakes entries will be declared to be made by the authorized account holder of the Third Party Social Network account used to enter. The authorized account holder is defined as the natural person who is assigned to a username by a Third Party Social Network. Participants must enter using only the Third Party Social Network account subscribed to and registered in his/her name. The potential winner may be required to provide Sponsor with proof that he/she is the authorized account holder of the user name/ Third Party Social Network account associated with the winning entry. Automated entries (including but not limited to entries submitted using any robot, script, macro or other automated services) are not permitted and will be disqualified. Sponsor reserves the right, in its sole discretion, to prohibit the participation of an individual if fraud, use of robotic, automatic, programmed or like entry methods, or tampering is suspected; if the individual fails to comply with any provision in these Official Rules; or acts in an unsportsmanlike or disruptive manner. If for any reason the Sweepstakes is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure, human error or any other cause beyond the control of Sponsor that corrupts or affects the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, Sponsor may, in its sole discretion, substitute prizes, amend these Official Rules, or discontinue the Sweepstakes at any time with or without notice; such changes will apply to all entries received prior to or after the change.
